Subscribe for mail-order service and your prescription will arrive every 90 days

CVS Pharmacy® on-demand delivery



Four-hour delivery when your home is within 10 miles of any CVS Pharmacy*

CVS Pharmacy® one- to two-day delivery



Free delivery by the United States Postal Service within one to two days**

If you're already filling your prescription at a local CVS Pharmacy, you can ask your pharmacist about switching to 90-day refills.

If you'd like to switch to mail order, you can call Customer Care at **1-888-Rx Aetna (1-888-792-3862) (TTY: 711)**.

* There's a small fee for this. Orders must be placed by 4 PM or four hours before the pharmacy closes, whichever is earlier, to ensure delivery within the same day. Orders placed after this time will be delivered the following day. The member must be home and 18 years or older to receive delivery. Delivery is limited to certain locations within a 10-mile radius of CVS Pharmacy® locations, and as allowed in accordance with state law, regulations and guidelines. Your delivery is provided at a special rate as part of your prescription benefits plan. You will be notified of the fee before you prepay for your delivery order.

** Most prescriptions eligible with qualifying health plans. The delivery period does not include Sundays or United States Postal Service holidays. Order cut-off times and delivery fees apply. Service is available at participating locations only. Delivery is not available to every address. Delivery prices may vary from store prices. Coupons and promotions may not be available with delivery orders. Other restrictions may apply. Ask the pharmacy staff for details.
